Dear ADM Privacy Officer / Madame, Monsieur,

I am writing on behalf of Ms. [REDACTED] (DOB [REDACTED] and her minor child [REDACTED] de [REDACTED] (DOB [REDACTED] as her designated representative.

This is a formal access request under the Personal Information Protection and Electronic Documents Act (PIPEDA) and the Act respecting the protection of personal information in the private sector (Quebec), with respect to the personal information that Aeroports de Montreal (ADM) holds about these two individuals.

The records are requested in the context of an ongoing judicial review proceeding before the Federal Court of Canada concerning events that occurred at YUL on March 20-22, 2026. Given that context, the preservation of the responsive records is a matter of particular urgency, as their loss could prejudice the evidentiary record before the Court.

**1. URGENT PRESERVATION REQUEST**

I respectfully ask that ADM immediately preserve, and not destroy or overwrite, any CCTV recordings and related records containing the personal information of Ms. [REDACTED] and the minor child, pending the processing of this access request. CCTV at YUL is typically retained for a short period (commonly around 30 days), and the loss of this footage would be irreversible.

**2. ACCESS REQUEST UNDER PIPEDA, PRINCIPLE 4.9**

Pursuant to PIPEDA Principle 4.9 (Individual Access) and to ADM's own Privacy Policy (Sections 5(a), 10, 11 and 14), I request access to all personal information that ADM holds about the two individuals identified above, specifically:

a) All CCTV / video recordings captured by ADM-operated cameras at YUL between March 20 and March 22, 2026, showing Ms. [REDACTED] and/or the minor child, including footage from:

- International arrivals hall and primary inspection area
- Passenger corridors connecting immigration screening areas
- Transit and holding zones adjacent to CBSA secondary inspection
- Common areas (food court, washrooms, seating zones) where the individuals were present
- Departure gates and boarding areas used on March 22, 2026

b) Any retention logs, access logs, or disclosure logs indicating whether and when these recordings were shared with third parties.

c) Any ADM security incident reports, notes, or communications referencing these individuals.

I am not attaching identification documents to this email for privacy and security reasons. I act as designated representative of Ms. [REDACTED] with her written authorization, and I am willing to provide identification and authorization documents through a secure channel upon request.

Please acknowledge receipt of this request and confirm the preservation of all responsive records as soon as possible.
