Dear Privacy Officer,

Thank you for your prompt follow-up. Below are the requested details to assist in locating and preserving the relevant CCTV footage.

1. FLIGHT INFORMATION

- Arrival: Air Canada AC925, Cancún (CUN) → Montréal (YUL), March 20, 2026, scheduled arrival 20:20 ET
- Departure: Air Canada AC924, Montréal (YUL) → Cancún (CUN), March 22, 2026, Gate A55, revised departure approximately 10:45 ET

2. TIME INTERVALS AT THE AIRPORT

Ms. [REDACTED] and the minor child were present at YUL continuously from the evening of March 20, 2026 (upon arrival) until the morning of March 22, 2026 (upon departure). They remained within the airport for the entire duration between these two flights.

3. AREAS OF THE AIRPORT

I request footage from all ADM-controlled areas where the individuals may have been present, including but not limited to:

- International arrivals hall and corridors after disembarkation
- Primary inspection area and adjacent corridors
- Waiting areas, lobby, and common spaces (seating, food court, washrooms)
- **Transit and holding zones**
- Departure area, boarding gates, and specifically Gate A55 on March 22

Given that the individuals were present at the airport continuously for approximately 36 hours, the specific areas they passed through are not all known to me. I therefore request complete and continuous footage from all areas where they may appear during this period.

4. INVOLVEMENT OF AUTHORITIES

Canada Border Services Agency (CBSA) officers were involved in interactions with the individuals during this period. This is the subject of an ongoing judicial review proceeding before the Federal Court of Canada.

5. CONTEXT

The footage is requested in the context of a judicial review filed before the Federal Court of Canada concerning decisions made at YUL on March 20-22, 2026 affecting Ms. [REDACTED] and her minor child (age 7, with severe medical conditions). The preservation and disclosure of this footage is material to the evidentiary record before the Court.

I respectfully reiterate the urgency of preserving all corresponding recordings given standard retention cycles, and I also request that
